

## Oil Country Powers Change Contest (“Contest”)

### OFFICIAL RULES

1. **SPONSOR:** This Contest is conducted and sponsored by Oilers Entertainment Group Canada Corp. and Capital Power Corporation (collectively, the “Sponsor”).
2. **CONTEST SUMMARY:** This Contest is held between February 17, 2025 and March 16, 2025 (the “Entry Period”). There are up to 5 Weekly Prizes for each of the 4 Weekly Draws (20 Weekly Prizes total) and 3 Grand Prizes available to be won in this Contest, as described in paragraph 10 (the “Prizes”). Eligible Entrants shall be selected for the chance to win the Prize in accordance with paragraph 7 below. The Selected Eligible Entrant will win the Prize as defined herein. The value of the Grand Prize is approximately \$4,000.00 and the value of each Weekly Prize ranges from approximately \$75.00 to 250.00.
3. **ELIGIBILITY:** To be eligible, you must be a student enrolled in Grade 10-12 in a school in Oil Country (defined as any locations in Alberta north of and including the City of Red Deer, Alberta). You are not eligible if, during the Entry Period, you are an employee or partner of the Sponsor or a member of the immediate family (defined as mother, father, brother, sisters, sons, daughters and husband or wife, regardless of where they reside) or household of any of the above persons, their respective affiliates, agents, licensors, associates, representatives and advertising agencies. All decisions regarding eligibility to enter this Contest will be determined by the Sponsor in its sole discretion. This Contest is void where prohibited by law.
4. **NUMBER, APPROXIMATE VALUE OF PRIZES AND CHANCES OF WINNING:** There are up to 5 Weekly Prizes for each of the 4 Weekly Draws (20 Weekly Prizes total) and 3 Grand Prizes available to be won in this Contest. The Prizes are described in paragraph 10 below. The chances of winning the Prizes will depend on the number of eligible entrants received in accordance with these rules during the Entry Period. The value of the Grand Prize is approximately \$4,000.00 and the value of each Weekly Prize ranges from approximately \$75.00 to 250.00.
5. **CONTEST SCHEDULE:** This Contest commences on February 17, 2025 and closes at 11:59 pm MST on the dates outlined in the Contest Schedule below (the “Contest Period”). Entries must be received before the Draw Closing Time (the “Draw Closing Time”) to be selected to win the Prize. The detailed contest schedule (the “Contest Schedule”) is set out below:

6. **HOW TO ENTER:** No purchase is necessary to enter this Contest. To enter Eligible Entrants must log on to the Sponsor’s website at [www.oilcountrypowerschange.com](http://www.oilcountrypowerschange.com) and complete an entry form (the “Entry Form”) and submit the Entry Form along with a photo or video submission the Entrant doing a good deed as per the options listed on the website (the “Submission”) before the Draw Closing Time. Submissions must be in accordance with the parameters of what is a valid submission according to the website in order to be considered a valid Submission. The Entry Form and Submission together are considered an “Entry”. Entries will only be accepted via [www.edmontonoilers.com](http://www.edmontonoilers.com). Illegible, incomplete, late or garbled Entries will be disqualified. No Entries will be accepted by any other means, including, but not limited to, in person or by mail.

Entries submitted during the Weekly Draw Contest Schedules will automatically be entered into the Grand Prize draw, but will not be entered for any other Weekly Draws aside from the Weekly Draw Contest during the time period the Entry is submitted.

Once submitted, Entries become the sole property of the Sponsor and will not be returned. No mechanically reproduced or photocopied Entries will be eligible for the Contest.

- 7. DRAW DETAILS:** A random draw for each of the Prizes will take place in accordance with the Contest Schedule above, at the offices of the Sponsor in Edmonton, Alberta. An Eligible Entrant can only win up to 1 Weekly Prize and 1 Grand Prize. The Eligible Entrant whose Entry is drawn (the “Selected Entrant”) and has complied with these Official Rules will be the winner of the Prize (the “Winner”).

If necessary, should the Prize be unclaimed, or should the Selected Entrant be unwilling, unable or ineligible to win the Prize as set out in these Official Rules, the Prize will be forfeited and the Sponsor shall have the right to draw, as replacements only, additional Entries. Those Eligible Entrants, if any, whose Entries are drawn as replacements will be contacted by email by the Sponsor.

The Selected Entrants and the Winners must comply with these Official Rules. All determinations of the Selected Entrants and the Winners by the Sponsor are final and binding. No communication with Entrants will be entered into except with Selected Entrants, except as otherwise stated in paragraph 20 herein. All matters related to the Draw and the verification of the eligibility of the Selected Entrants to be declared the Winners shall be conducted by the Sponsor, or by persons designated by the Sponsor in its sole and absolute discretion. All decisions made by the Sponsor in this regard are final and binding and cannot be challenged.

- 8. NOTIFICATION:** The Sponsor will contact the Selected Entrant by email within 24 hours of the Draw Date according to the Contest Schedule at which time they will be asked a skill-testing question to claim the Prize. If the Selected Entrant does not contact the Sponsor within 48 hours of being contacted by the Sponsor, the Prize will be forfeited and the Sponsor may contact, as replacement only, an alternate Entry.
- 9. DECLARATION OF WINNERS:** The Selected Entrant will not be declared a Winner until:
- (a) The Sponsor has determined that the Selected Entrant is an Eligible Entrant pursuant to these Official Rules;
  - (b) The Selected Entrant correctly answers, without assistance of any kind, whether mechanical, electronic or otherwise, a skill testing question as set out in these Official Rules; and
  - (c) The Selected Entrant executes a release and waiver.
- 10. WEEKLY PRIZES:** There will be 5 Weekly Prizes for each of the 4 Weekly Prize Draws (total of 4 Weekly Prizes), each consisting of 1 of the following as determined by a random selection by the Sponsor in its sole discretion:
- (a) 1 \$500.00 Best Buy gift card;
  - (b) 4 tickets to a suite to an Edmonton Oil Kings home game the date of which is determined by the Sponsor in its sole discretion;
  - (c) 1 Edmonton Oilers jersey;
  - (d) 1 Edmonton Oilers merchandise package, consisting of 1 Oilers hat, 1 Oilers sweater, 1 Oilers t-shirt and 1 Oilers fan chain; or
  - (e) 1 Edmonton Oilers item selected by the Sponsor in its sole discretion, autographed by an Oilers player as determined by the Sponsor in its sole discretion.

**GRAND PRIZE:** There will be 3 Grand Prizes, each consisting of:

- (a) 4 tickets to a suite to an Edmonton Oilers home game (the “Oilers Game”), the date of which is determined by the Sponsor in its sole discretion;
- (b) A pre-game tour of Rogers Place prior to the Oilers Game; and
- (c) A meet & greet with a member of the Oilers Alumni at the Oilers Game.

Prizes are not transferable and must be accepted as awarded with no substitutions, except at the Sponsor’s sole discretion. Any income taxes and any other expenses not explicitly specified as part of the Prize in paragraph 10 herein, including without limitation transportation, parking, gratuities, entertainment, food and beverages, and other souvenirs and items, are each the Winner’s sole responsibility. The Sponsor reserves the right to substitute a Prize of equivalent monetary value if it is unable to award the Prize as described. The Sponsor will not be responsible, however, if weather conditions, event cancellations, or other factors beyond the Sponsor’s reasonable control prevent the Prize from being fulfilled. In any such event, the Winner will not be provided with a substitute prize or cash equivalent. The Prize will only be granted to the verified Winner.

If, for any reason, the Contest is not capable of running as planned, due to causes beyond the reasonable control of the Sponsor which corrupt or affect the administration, security, fairness, integrity or proper conduct of this Contest, the Sponsor reserves the right, in its sole discretion to cancel, terminate, modify or suspend the Contest.

DISQUALIFICATION:** The Sponsor reserves the right, in its sole discretion, to disqualify any Entrant or Selected Entrant it finds to be: (a) tampering or attempting to tamper with the entry process or the operation of the Contest, or the Oilers website, [www.edmontonoilers.com](http://www.edmontonoilers.com); (b) violating these Official Rules; or (c) violating the terms of service, conditions or use and/or general rules or guidelines of any website property or service. **CAUTION:** Any attempt by an Entrant or any other individual to deliberately damage any website or undermine the legitimate operation of the Contest may be a violation of Criminal or Civil laws.
- If an Entrant or Selected Entrant is disqualified for any reason, another entry will be selected from the remaining eligible entries received as set out in these Official Rules. The Sponsor will contact those additional Selected Entrants by email.

RELEASE AND INDEMNIFICATION:** By entering the Contest, each Entrant: (a) releases and holds harmless the Sponsor and its directors, officers, employees, parent companies, subsidiaries, affiliates, suppliers, sponsors and agents from any and all liability for injuries, loss or damage of any kind to persons, including death, or property damage, resulting in whole or in part, directly or indirectly, from acceptance, possession, use or misuse of any Prize, participation in this Contest, or participation in any Prize-related activity; and (b) agrees to fully indemnify the Sponsor and its directors, officers, employees, parent companies, subsidiaries, affiliates, suppliers, and agents from any and all claims on the part of any third party or parties related in any way and for any reason to the Contest or to the Prize including, without limitation, death, or personal or property damage or injury.

The Sponsor is not responsible for any incorrect or inaccurate information, whether caused by website users or by any of the equipment or programming associated with or used in the Contest or by any technical or human error which may occur in the processing of Entries. The Sponsor assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, Entries. The Sponsor is not responsible for any problems, failures or technical malfunction of any telephone network or lines, computer online systems, servers, providers, computer equipment, software, e-mail, players, or browsers, on account of technical problems or traffic congestion on the Internet, at any website, or on account of any combination of the foregoing. The Sponsor is not responsible for any injury or damage to Entrants or to any computer related to or resulting from participating or downloading materials in this Contest. - 18. LAWS:** These are the official Contest rules. This Contest is subject to all applicable federal, provincial and municipal laws and regulations. These Contest rules are subject to change without notice in order to comply with any applicable federal, provincial and municipal laws or the policy of any other entity having jurisdiction over the Sponsor.
- 19. CONSTRUCTION:** The invalidity or unenforceability of any provision of these Official Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Official Rules shall otherwise remain in effect and be construed in accordance with their terms as if the invalid or illegal provision were not contained in these Official Rules.
